

Cement sector seeks higher supply from Neyveli Lignite

Chennai, Sept 4: Faced with shortage of supply, the cement industry is seeking more raw material from the Neyveli Lignite Corporation (NLC). Representatives of the cement industry said that they need at least 1.30 lakh tonne of lignite per month and expressed readiness to enter into a fuel-supply agreement with NLC.
