

BJP announces its candidates for by-polls

Bharatiya Janata Party on Thursday declared its candidates for the upcoming Assembly by-elections in Vijayraghgarh, Bahoriband and Agar constituencies.

Sanjay Pathak will contest from Vijayraghgarh, Pranav Pandey from Bahoriband and Gopal Parmar would contest from Agar seat.

Pathak had quit the Congress during Lok Sabha Elections and joined the BJP. Pathak had resigned his assembly membership. Now he would contest by-elections on the same seat from BJP. Pandey, who would contest from Bahoriband seat, is son of former MLA Prabhat Pandey, who had passed away recently. Another candidate Parmar, has been an MLA in the past and he is being seen as choice of BJP organisation.
