Surendra Rajput 'Tiger', is a known associate of Kamal Patel and an active member of the ruling BJP. He was admittedly apprehended by the police but then allowed to escape.

The petitioner has alleged that as there were enough evidences on the record to

prove that riot was not the act of public anger, but it was instigated and was work of conspiracy by Kamal Patel and his sons and their associates and police has acted partial in the matter, the investigation into the matter be transferred to the CBI.

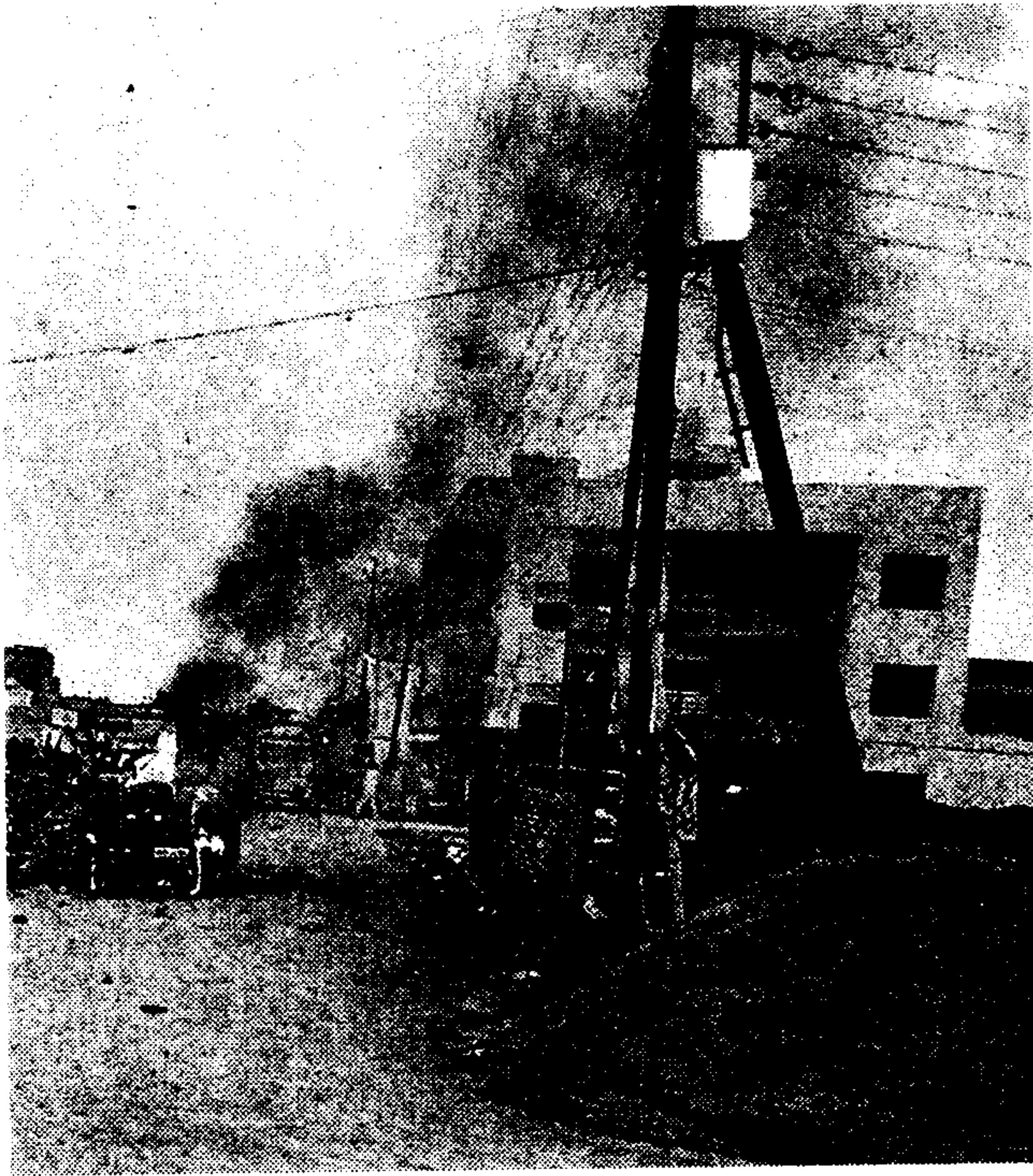

गुस्साए लोगो ने ट्रैक्टर में आग लगा दी। चालक मौके से फरार हो गया। पुलिस के मुताबिक मोटरसाइकिल फिसलकर अचानक ट्रैक्टर से जा टकराई और बाइक पर बैठा दीपक उछल कर ट्रैक्टर के पहिए के नीचे आ गया, जिससे मौके पर ही दीपक की दर्दनाक मौत हो गई। उधर, पोते की मौत को अपनी आंखों के सामने, कुचलता देख दादी को ऐसा सदमा लगा की वह बेहोश हो गई। तत्काल आसपास के लोगों व पुलिस के सहयोग से बेहोश दादी और बेटे को इलाज के लिए अस्पताल पहुंचाया गया।

मृत बच्चे की देह पोस्टमार्टम के लिए मचुरी भेजा। जब दादी को अपने पोते की मौत की सूचना मिली तो सदमे में दादी भी चल बसी। इधर, फायर ब्रिगेड ने मौके पर पहुंच कर आग बुझाई। पुलिस ने ट्रैक्टर जब्त कर चालक के खिलाफ मामला दर्ज कर लिया। वहीं अज्ञात लोगों के खिलाफ ट्रैक्टर को आग लगाने का प्रकरण भी दर्ज किया गया है।
