Chance for both India, Sri Lanka to claim No. 1 ODI ranking

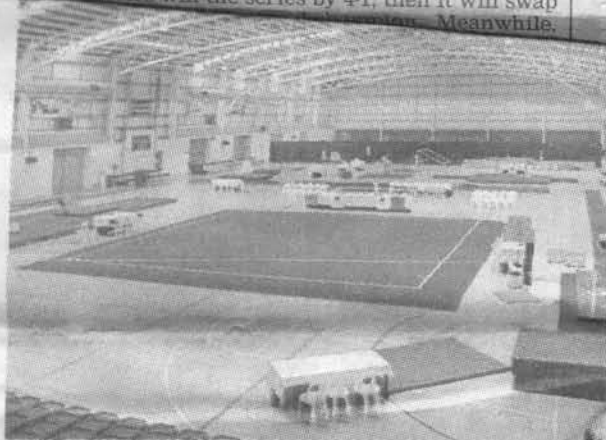
Dubai

Currently placed at number three behind South Africa and Australia, India have an opportunity to jump to the top in the ICC ODI team rankings if they win the upcoming five-match one-day series against Sri Lanka 4-1 or better. A 4-1 series win will put India at par with South Africa on 115 ratings points, but when the ratings are calculated beyond the decimal point, then they will be ranked number one. A 5-0 sweep will mean India will take a two-point lead over South Africa.

India are now leading fourth-ranked Sri Lanka by two ratings points. Even Sri Lanka have a fair chance of climbing up to No. 1 position in the table, but it would be a challenging task, as the Islanders will have to win all their five matches in order to achieve that, the ICC said in a statement.

If Sri Lanka are able to win all five matches, they will join South Africa on 115 ratings points but will be ranked number one by a fraction of a point.

The largest Indoor stadium in south India is coming up at Mundayad in Kannur district of Kerala as part of the 35th edition of the National Games, to be held in the state next year. The 2,600 sq. ft. stadium, which can accommodate 3,000 spectators, is scheduled to host the basketball and wrestling competitions during the much-awaited multi-sporting

SUPER SUB TOLGAY REGISTER FIRST WIN FOR FC GOA

MARGAO: Substitute Tolgay Ozbey scored an injury time goal as dominant FC Goa rallied from behind to beat Delhi Dynamos 2-1 and register their maiden win in the inaugural Indian Super League, here Saturday. Ozbey snatched the winner for the FC Goa in the 90th minute before Shaikh Jewel Raja (72nd) equalised for the hosts after the Dynamos were put ahead as early as in the seventh minute of the match by skipper Mads Junker. The win takes FC Goa up the table with four points from five matches, while the Delhi side remained on six points from five games. FC Goa coach Zico made three changes bringing in Mandar Rao Dessai, Romeo Fernandes and Jewel Raja and the move paid off as the trio put the opponent under tremendous pressure, especially in the second half to score the stunning win.
