MEGHALAYA MINE RESCUE OPERATION Navy divers detect a body, spot skeletons

Navy divers have found a body in a flooded rat-hole coal mine in Meghalaya's East Jaintia Hills district and spotted some skeletons in the area, weeks after a multi-agency search operation was launched to rescue 15 trapped miners, officials and sources said Thursday.

Navy Spokesperson Capt D K Sharma said in New Delhi that the Navy divers detected the body using a remotely operated vehicle (ROV) at a depth of approximately 160 feet and 210 feet inside the rat hole mine on Wednesday night.

The body, which is yet to be identified, has been pulled upto the 'mouth' of the mine and is being retrieved under the supervision of a team of doctors,


