Officers are less than able to persuade him of any issue. The ACS only says he is acquainted with everything. The officer remains present in every important meeting and interferes in every affair. The ACS is not on good terms with the minister of the department, but since the government has yet to find an alternative to him, he cannot be transferred to another place. The ACS is also issuing warning that, if any action is taken against him he will go to court. But the officer who is known for his sound temperament is looking scared. The ACS fears that a senior officer may take action against him. So he is worried about it.

The ACS has barely had any interest in her work, and she is simply passing time. She has kept away from taking charge of any important department. She went on leave when she was shifted to an important unit. The lacklustre attitude of the ACS has made the employees in the department very happy. Since the ACS rarely objects to giving her nod to any file things are moving the way they want.

wo female IAS officers are all set to get important **▲** departments. One of them posted to a federation in the state capital may be appointed as collector of any district in coming days. During the BJP rule, this female officer was shifted from a district after she had picked a fight with a leader of the then ruling party. So she was deprived of any field posting after that incident. Around 54,000 people were evacuated from the southern Italian city of Brindisi on Sunday as experts worked to defuse a World War II bomb, in the largest operation of its kind in the country, media said.

The British bomb, onemetre (three-feet) long and weighing 200 grammes (440-pounds), was found on November 2 during work on a cinema.

The device was damaged by the workers' equipment, making the operation more tricky.

All residents within a 1.5-kilometre radius were evacuated, and gas supplies were cut in homes within 500 metres of the site.

Some air traffic and rail services were also suspended.
