इंदौर। घर के पास कुत्ते को लेकर टहल रहे एक बुजुर्न को सफेद रंग की कार ने टक्कर मार दी। घटना के वक्त उनका बेटा छत पर खड़ा था। हादसे की आवाज रानकर नीचे भागा। देखा पिता कुछ दूरी पर महनी पड़े थे। बेटे ने पिता को अगराय को अस्पताल पहुंचाया. गहां कुछ दे बाद उनकी मौत हो गई। द्वारकापुरी पुलिस के अनुसार कुंदन नगर में रहने वाले 72 वर्षीय बजमोहन परिहार की चाल ७२ वद्याच ब्रजनाहरू पारहार का रविवार दोपहर को सड़क हादसे ने नौत हो गई। परिजन ने पुलिस को बताया परिसर जब घर से थोड़ी दूरी पर टहल रहे थे. तभी अवानक किसी के टकराने की आवाज आई। छत पर खडे बेटे ने सुना और नीचे देखा तो एक कार टक्कर मारकर भाग रही थी। उसने भागकर पिता को उत्तरमा और मंतरकुओं के एक निजी अस्पताल पहुंचाया। वहां उन्हें वेंटीलेटर पर रख गया, लेकिन कुछ घंटे बाद उनकी मौत हो गई। फिलहाल पुलिस कार की लाश तक रही है।

Raj Bhavan has reported three more Covid-19 cases on Monday taking the tally to 15. This time, three security personnel of the battalion deployed at Raj Bhavan have been diagnosed with infection. Previously, Raj Bhawan staff living in staff quarters in the campus were tested positive for the infection.

State capital on Monday added 40 new COVID-19 cases pushing the infection tally to 2626 with 81 fatalities so far. Six members of family in Bagsewania and four members of a family in Kohe-Fiza were among those

tested positive on the day. Driver of BJP MLA Om Prakash Saklecha has also contracted corona.

An Asha worker in Anna Nagar slums, a pregnant woman in MP Nagar are among the fresh corona cases that surfaced on the day. Three positive cases were reported each from Bairagarh and Shahjahanabad areas. SDM Rajesh Gupta said,

"In Bagsewania area, six members of a family have been tested positive for the infection. Earlier, one person of the

family was diagnosed with it on Monday, his wife, sisterin-law and other family members tested positive.

Eight families of the slum have been shifted to quarantine centre.

Similarly, four member of a family in Koh-e-Fiza were diagnosed with corona, while one case surfaced from Signature99, Kolar, informed

So far 13 personnel of Rapid Action Forces (RAF), Obedullaganj, Raisen, who were deployed in Bhopal during lockdown, have been tested positive for the infection and are undergoing treatment at AIIMS. It is serious matter for the district administration as 50 jawans are reportedly taken ill and their swab samples have

been collected.

The incubation period of covid-19 is 14 days. If someone has come in contact with a corona patient, he develops the symptoms of the disease after 14

The legislators whose swab sample test report was negative have to undergo another examination after two days.

The leaders, present at the BJP office from 17 to 12 for RS elections, are taking precautions. Doctors also advised the legislators that if they see any symptoms of the disease they should immediately seek medical advice.

Meanwhile, the condition of Saklecha and his wife is improving. The couple is not down with fever, and their oxygen level is normal.
