Gunman kills 3 people, then himself at Michigan University

AP / East Lansing (US)

A gunman opened fire on Monday night at Michigan State University, killing three people and wounding five more, before fatally shooting himself off campus amid an hours-long manhunt during which frightened students hid in the dark.

Police reported the man's death early Tuesday, four hours after shootings broke out, first at Berkey Hall, an academic building, and then nearby at the MSU Union, a popular hub to eat or study.

"This truly has been a nightmare we're living tonight," said Chris Rozman, interim deputy chief of the campus police department. Hundreds of officers had

scoured the East Lansing campus, about 90 miles northwest of Detroit, for the suspect, whom police described as a short black man with red shoes, a jean jacket and ball cap. Rozman said it was too

early to know a motive and whether the man had some type of affiliation with the university. His name was not immediately released.

"There's a lot that we don't know at this point," Rozman said.

Saudi woman set to break barrier with space mission

Saudi Arabia will send its first ever woman astronaut on a space mission later this year, according to a state media report.

Rayyana Barnawi will join fellow Saudi male astronaut Ali Al-Qarni on a mission to the International Space Station (ISS) "during the second quarter of 2023", the official Saudi Press Agency said on Sunday.

They'll become the first Saudi Arabians to travel to the ISS and just the second and third people from the kingdom ever to reach space. And Barnawi will be the first Saudi woman to make it to the final frontier. "Human spaceflight is a symbol of countries' superiority and global competitiveness in many fields such as technology, engineering, research and innovation," a press release from the state-run Saudi Press Agency reads.

As its name suggests, Ax-2 will be the second mission to the ISS organised by Axiom Space.

The first, Ax-1, sent three paying customers and Axiom's Michael López-Alegría, a former NASA astronaut, to the station for more than two weeks in April 2022 aboard a SpaceX Dragon capsule.

The US does not quite know what it has shot off the skies in the last three instances, but officials assured Americans on Monday that they were not alien airships.

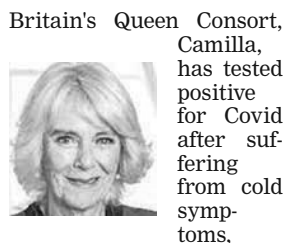

"I know there have been questions and concerns about this, but there is no - again, no indication of aliens or extraterrestrial activity - with these recent take-downs," Karine Jean-Pierre, the White House press secretary, said to reporters.

President Joe Biden has directed the US Intelligence community to do a "broad assessment" of China's intelligence capabilities after assuming office, the White House said following the

detection of a spy balloon and high-altitude flying objects over American airspace.

In recent days, there have been three incidences of balloon sightings in the US. A US F-22 fighter jet on Saturday shot down an

unidentified cylindrical object over Canada, a day after another similar object was downed near Alaskan waters, and a week after the American military brought down a suspected Chinese surveillance balloon off the South Carolina coast.
